
### Dr. Gabriele Magni, Director | Global Policy Institute

An assistant professor in the Department of Political Science and International Relations, Magni teaches classes on comparative and European politics, political economy, and LGBTQ politics. His scholarly work explores how economic and identity factors interact to shape political preferences and voting behavior in advanced democracies. Magni's research on the political consequences of economic inequality, immigration, and LGBTQ politics has been published in several top peer-reviewed academic journals including the American Political Science Review, the American Journal of Political Science, the Journal of Politics, and the British Journal of Political Science. His expertise has been sought-out and featured in The Washington Post, Politico, The New Republic, and The New York Times, among other academic and non-academic venues. A first-generation college student, Magni grew up in Italy, obtained his Ph.D. from UNC-Chapel Hill, and completed a postdoc at Princeton University before coming to LMU to join the BCLA faculty in fall 2019.



Dr. Gene Park, Senior Fellow and Former Director | Global Policy Institute

Gene Park's research interests include comparative and international political economy; Japanese foreign policy and politics; and the politics of monetary policy, public spending and taxation. He also has a broad interest in East Asian security. His most recent co-authored book is "Taming Japan's Deflation: The Debate over Unconventional Monetary Policy" (Cornell University Press, 2018). An earlier book, "Spending without Taxation: FILP and Politics of Public Finance," was published in 2011 (Stanford University Press). He earned a B.A. in Philosophy from Swarthmore College and Ph.D. in Political Science from University of California Berkeley. He is an avid tennis player.





Jonathan Pollack is Distinguished Scholar of Strategic Studies in the Global Policy Institute at Loyola Marymount University, where he teaches seminars on post World War II strategy and policy in East Asia and Chinese power and policymaking. He is also Non-Resident Senior Fellow in Foreign Policy at the Brookings Institution. During his tenure at Brookings he served as Director of the John L. Thornton China Center and later as holder of the SK-Korea Foundation Chair in Korea Studies. Prior to joining Brookings, he was Director of the Strategic Research Department at the US Naval War College and was previously Head of the Political Science Department and Corporate Research Manager for International Policy at RAND. He has also taught at Brandeis University, the RAND School of Policy Studies, UCLA, and the Naval War College.

Dr. Pollack earned his M.A. and Ph. D. at the University of Michigan, and was subsequently a post-doctoral research fellow at Harvard University.

His primary research interests include East Asian security and development; the politics and foreign policies of China; political and strategic futures on the Korean Peninsula; and US policy in Asia and the Pacific. His publications include Strategic Surprise? US-China Relations in the Early 21st Century; Korea-The East Asian Pivot; Asia Eyes America: Regional Perspectives on US Asia-Pacific Strategy; and No Exit: North Korea, Nuclear Weapons and International Security. His current research focuses on the uncertainties and risks to regional order in East Asia.

Matt Lamantia, Undergradaute Research Fellow | Global Policy Institute



# **Our Global Policy Institute Fellows:**

### David Glazier, Global Policy Institute Senior Fellow

Dave Glazier is a professor at Loyola Law School, Los Angeles with an affiliated appointment in political science at LMU. He spent 21 years as a U.S. Navy surface warfare officer, culminating in command of a guided missile frigate, before retiring in order to attend law school at the University of Virginia. He researches and teaches international law with a particular focus on law governing the use of force and the law of the sea. He has published multiple law journal articles and book chapters on issues related to the so-called "War on Terror," including the Guantanamo military commissions and drone use.

### Daniel Jacobs, Global Policy Institute Senior Fellow

Daniel Jacobs, clinical associate professor of management at LMU, has had a distinguished career in both academia and public service. He was the founding director of the first interdisciplinary graduate program in sustainability management in a U.S. business school, which he led to a #1 national sustainability specialty ranking by Bloomberg Businessweek in 2013. Following the Taliban takeover of Afghanistan after the United States' decision to leave the country, the Global Policy Institute was joined by experts Heather Barr, Associate Director of the Women's Rights Division and former Afghanistan researcher, Human Rights Watch; former ambassador to Afghanistan (2005-2007) Ronald E. Neuman; and Dr. Orzala Nemat, Director of the Afghanistan Research and Evaluation Unit (AREU). The panelists explored with particular detail the changing position of women in Afghan society, comparing their place in the pre-war country with the post-Taliban takeover context. With the Taliban seizing control, uncertainty has taken hold over the condition of Afghan women with regard to education and leadership. The panelists agreed that the US withdrawal from Afghanistan will have long-lasting geopolitical effects, both for Afghanistan and America's role in the international community, with the reliability of the United States called into question.

Hunklinger addressed issues related to coalition building, inter-party politics, and the implications of the German election on European politics as a whole.

Clarissa Ward joined the Global Policy Institute to discuss her 20-year career as a conflict journalist, having reported from Syria, Iraq, Afghanistan, Egypt, and Ukraine for CNN, ABC, CBS, and Fox News. Ward shared with GPI how she got started in journalism after studying comparative literature at Yale University and following 9/11. Ward then shared experiences from reporting in such conflict zones as Baghdad and Kabul, in addition to Syria, highlighting the horrors of war and reporting from these environments. Ward offered insight into the experience of being a woman in journalism, remarking on the unexpected advantages she had in the field, such as being perceived as non-threatening and being able to better connect with women in conflict zones. Finally, Ward gave advice to students hoping to enter into the journalism field: listen, learn, and be humble.



On October 21, the Global Policy Institute hosted Frederica Mogherini. Ms. Mogherini served as High Representative of the European Union for Foreign Affairs and Security Policy and as Vice-President of the European Commission from 2014-2019. She also served as Italy's Minister for Foreign Affairs and International Cooperation and as Member of the Italian parliament. In conversation with GPI Director Gabriele Magni, Ms. Mogherini shared her insights into such issues as the United States; withdrawal from the Paris Climate Agreement and the Iran Nuclear Deal. She discussed the change that the Trump presidency demarcated for U.S-European relations and she noted how the Biden victory came as a relief to many Europeans, even though Europe understands now more than ever the importance of strategic autonomy. Mogherini also discussed the importance of the relations with China, a country that should be called out for violation of human rights but that also remains an indispensable player to tackle global challenges such as climate change. Mogherini ended the talk by sharing her optimism for the future, due in large part to youth activism and critical engagement.



Steven Pifer, Former U.S. Ambassador to Ukraine

In less than a month, Putin's war of choice against Ukraine caused the largest crisis in Europe since World War II. Innocent civilians have been killed and targeted with millions more displaced, all while the Kremlin took censorship to new extremes.

The event aimed to provide GPI's audience and the LMU community with adequate information about the complexity of the conflict and the devastating humanitarian crisis in Europe. Various experts shared their knowledge and perspective to help the community understand the serious consequences of this tragedy and find meaningful ways to support those affected by the war.



The first segment hosted former U.S. Ambassador Steven Pifer. Amb. Pifer served as ambassador to Ukraine (1998-2000) and deputy assistant Secretary of State in the Bureau of European and Eurasian Affairs with responsibilities for Russia and Ukraine (2001-2004)..

The second segment titled *Voices from Ukraine & Perspectives from Russia* featured a conversation among Ulia Gosart (UCLA), Cyril Hovorun (LMU) and Nigel Raab (LMU). The 2022 Global Policy Institute Book Award was Presented to Dr. Richard Falk, author of *Public Intellectual: The Life of a Citizen Pilgrim*.

**About the Author:** Dr. Falk is a member of the Editorial Boards of *The Nation* and *The Progressive*, and Chair of the Board of the Nuclear Age Peace Foundation. He is a former advisory board member of the World Federalist Institute and the American Movement for World Government. In 2008, the United Nations Human Rights Council (UNHRC) appointed Falk to a six-year term as United Nations Special Rapporteur on the situation of human rights in the occupied Palestinian territories. The event included a small reception and a subsequent speech from Dr. Falk about his book and the thought process behind it. After his speech, the audience was able to ask him questions about his work and other topics.

**About the Book:** This political memoir reveals how Dr. Richard Falk became prominent in America and internationally as both a public intellectual and citizen pilgrim. Dr.Falk built a life of progressive commitment, highlighted by visits to North Vietnam where he met PM Pham Von Dong, to Iran during the Islamic Revolution after meeting Khomeini in Paris, to South Africa where he met with Nelson Mandela at the height of the struggle against apartheid, and frequently to Palestine and Israel. His memoir is studded with encounters with well-known public figures in law, academia, political activism and even Hollywood. Dr. Falk mentored the thesis of Robert Mueller, taught David Petraeus.


His publications and activism describe various encounters with embedded American militarism, especially as expressed by governmental resistance to responsible efforts to rid the world of nuclear weapons, and his United Nations efforts on behalf of the rights of the Palestinian people. In 2010 he was named Outstanding Public Scholar in Political Economy by the International Studies Association. He has been nominated annually for the Nobel Peace Prize since 2009



### Is the U.S. A Reliable Ally? Evidence from a Survey of U.S. Voters

The Biden administration has a clear position on U.S. commitment with regards to foreign conflicts. For example, in Ukraine, U.S. involvement has consisted in providing military and other aid as well as imposing harsh economic sanctions towards Russia. However, it has avoided direct military engagement with Russia to prevent an outbreak of war. The war has raised larger questions about the U.S. capabilities and commitment to formal allies that it has vowed to defend. This conversation analyzed U.S. voter support for aiding allies based on a series of survey experiments. The speakers explored the effects of partisan polarization on levels of public support for a key ally like South Korea and discussed the larger implications for the U.S.-led global alliance system.




Film Premiere: Code Red: An Exploration of Degrowth Economics

Degrowth Economics throws conventional economics on its head and ushers in a new 'utopian' vision of prosperity. This documentary, created by GPI Undergraduate Fellow Declan Tomlinson, explores the growing discourse of degrowth economics, which critiques the current status quo of economic thought. The film includes interviews with scholars around the world who are studying different aspects of this school of thought, synthesizing them into a digital research project. The film outlines the history of degrowth in action and provides new examples of what degrowth looks like in practice. It evaluates whether degrowth can solve systemic problems, including climate change, and analyzes the feasibility of implementation on a global (or even national) scale.

Domestic and Geopolitical Realignments: Implications for the ROK-US alliance

Evidence from a survey experiment of U.S. voters

The Global Policy Institute released its new policy brief: "Domestic and Geopolitical Realignments: Implications for the ROK-US alliance" authored by Veronica Backer-Peral, former GPI Undergraduate Fellow and Dr. Gene Park, Professor and Chair of the Department of Political Science and International Relations.

The purpose of the study is to examine the effects of partisan polarization on how U.S. voters view commitment to U.S. allies, in this case, South Korea (formally the Republic of Korea or ROK). Donald Trump came to office on an "America First" platform and used strong language to characterize allies as "ripping us off." Polling has suggested a significant




divide in terms of how Democrats and Republicans view alliances, military force, the role of diplomacy and more. Experts have warned that such polarization can have long-term harmful effects on U.S. foreign policy by undermining its credibility, ability to make long-term commitments and more.

Backer-Peral and Park's study uses survey experiments on U.S. voters to examine different partisan reactions to conflict scenarios that might require the U.S. to aid South Korea. Their finding suggests that there are indeed important differences, and that partisan priming can reduce or increase U.S. voter support for defending South Korea, its formal ally. Republicans, though, are more sensitive to such partisan priming than Democrats. Read the report for details and the larger policy implications.




